Halifax County Schools is committed to creating a supportive and positive learning environment to address the needs of the whole-student in partnership with educators, staff, parents and communities.

Organization History

The North Carolina (NC) Department of Commerce has ranked Halifax County, NC as a Tier 1 county. indicating it is one of the 40 most economically stressed counties in the state. It is one of the oldest counties in North Carolina. Once railroads replaced river transportation, the county experienced a continued economic decline. U.S. Census data from 2010 show the total county population is 52,849. The population demographics are as follows: African American-53%, White- 39%, American Indian- 4%, Hispanic- 2.6% and 2 or more Races 1.4%. The median household income here is \$32,549, compared to the state average of \$48,256. The poverty rate in Halifax County stands at 26.8% compared to the state average of 15.4%. The education level of Halifax County lends itself to labor or service industry employment as 76.8% of residents have a High School Diploma and only 13.4% hold a Bachelor's Degree. HCS serves 2,566 students in 10 schools across the county. The school setting is rural. The student racial/ethnic breakdown consists of: African-Amerian-84.4%,

American Indian-5.6%, White-4.3%, Hispanic-3.7%, other groups-<2%. HCS participates in the School Nutrition program and 100% of the student population qualifies for free lunch. Many of the students are struggling academically and it has negatively impacted the school system. According to the NCDPI website, the cohort graduation rate for 2016-17 in Halifax County Schools is 74.3% compared to the state average of 86.5%. The school system has six of its ten schools identified on the 2016-17 Priority Schools list.

Title: Young Writers Poetry Workshop Program (YWP)

Description: YWP is a ten-day session poetry writing enrichment project with an emphasis on leadership through creative writing for 5th-grade students in Halifax County Schools (HCS).

The program engaged effective strategies for creative writing instruction and made it accessible to young people -- particularly those whose voices may otherwise go unheard. The artist in residency (Mr. Phillip Shabazz) offered students an original curriculum and exceptional support services to increase their poetic writing skills and academic awareness of the use of language. In particular, students expressed examples of leadership through poetry writing and a love for a creative form of language expression through reading and writing.

Compatibility: Given HCS's focus on closing the achievement gap, and willingness to work with community arts partners to develop tomorrow's leaders, we believe the YWP provided a suitable match of instruction and support for the event sessions.

Goals: To offer students relevant and authentic learning experiences, such as interacting with a professional teaching artist and publishing their work in a school anthology, organized public readings, and an online venue for the sharing of their work. To increase students' use of language skills by engaging them with a relevant theme (leadership) helping them to develop a variety of key literary terms. To increase students' cultural awareness through enrichment activities. Increase the number of parents involved in the project. Improve students' awareness of influence through leadership and relationships.

The Program Material: Our Leadership and Creative Writing Curriculum is aimed at 5th-grade students and contains specific learning goals, pre-and post-assessment tools, and fully-packaged lesson plans that cover a wide variety of literary terms and topics. Each lesson included a pre-writing activity, directions for implementation, suggested reading, worksheets to assist in reading comprehension, engaging post-reading activities, public speaking, and a creative writing project. Students wrote original poems and short prose in the form of rhymes and free verse. Time was allotted to discuss exemplary sample writing, work from prompts, and write first drafts and revisions followed by a segment of students reading aloud their work which is a celebratory session in a whole school setting, and times for peers to engage them in question and answer segments about the composition of their work.

Leadership Themes:

Pittman Elementary Leadership Academy is a school of leadership. The leadership theme engaged age and grade-appropriate subject matter and included (but was not limited to) personal experiences, identity, historic

memories, and observations of family and friends' impactful leadership. Students connected with their core beliefs, decisions, and choices, and came away from the sessions with new leadership perspectives and ideas for improving their writing. The Open-Mic/Poetry Slam was the culminating session that emphasized a special event to showcase students' accomplished writing and public speaking. Certificates of achievement acknowledged for the winners: 1st, 2nd, 3rd, and Honorable Mention awards in the Slam, but also for each student who completed the program.

Duration: Each session lasts up to two hours. Dates: February 14-19, and April 11-14, 2022.
