## III. PROCEDURAL RIGHTS

# Appeal and Hearing Rights

- To appeal to the superintendent from any final administrative decision of school personnel and thereafter to petition the local board for a hearing; appeals of student discipline or alleged violations of law or State Board or local board policy have an automatic right of appeal to the board (G.S. 115C-45(c))
- To request bus transportation and appeal an adverse decision to the local board (G.S. 115C-244(d))
- To request school reassignment and to appeal reassignment decisions to the local board (G.S. 115C-369)
- To receive a hearing before a student is suspended for longer than ten school days and to appeal an adverse hearing decision to the local board (G.S. 115C-390.8, -390.10, -390.11)
- To appeal a decision of school officials re: student's eligibility, school selection, or enrollment as a homeless student to the superintendent and thereafter to the board (G.S. 115C-366(a2) and 16 N.C.A.C. 6H .0115)



# Other Procedural Rights

- Grievance process for complaints regarding exercise of a student's right to engage in prayer and religious activity, including the right to appeal to the board (G.S. 115C-407.31)
