##### Seeing Structure in Expressions

*Interpret the structure of expressions.*

<b>Arithmetic with Polynomial Expressions</b> <i>Perform arithmetic operations on polynomials.</i>	
<b>NC.M1.A-APR.1</b>	Build an understanding that operations with polynomials are comparable to operations with integers by adding and subtracting quadratic expressions and by adding, subtracting, and multiplying linear expressions.
<b>Arithmetic with Polynomial Expressions</b> <i>Understand the relationship between zeros and factors of polynomials.</i>	
<b>NC.M1.A-APR.3</b>	Understand the relationships among the factors of a quadratic expression, the solutions of a quadratic equation, and the zeros of a quadratic function.
<b>Creating Equations</b> <i>Create equations that describe numbers or relationships.</i>

<b>Reasoning with Equations and Inequalities</b> <i>Solve equations and inequalities in one variable.</i>

Functions	
<b>Interpreting Functions</b> <i>Understand the concept of a function and use function notation.</i>	
<b>NC.M1.F-IF.1</b>	Build an understanding that a function from one set (called the domain) to another set (called the range) assigns to each element of the domain exactly one element of the range by recognizing that: <ul style="list-style-type: none"><li>• if <math>f</math> is a function and <math>x</math> is an element of its domain, then <math>f(x)</math> denotes the output of <math>f</math> corresponding to the input <math>x</math>.</li><li>• the graph of <math>f</math> is the graph of the equation <math>y = f(x)</math>.</li></ul>
<b>NC.M1.F-IF.2</b>	Use function notation to evaluate linear, quadratic, and exponential functions for inputs in their domains, and interpret statements that use function notation in terms of a context.
<b>NC.M1.F-IF.3</b>	Recognize that recursively and explicitly defined sequences are functions whose domain is a subset of the integers, the terms of an arithmetic sequence are a subset of the range of a linear function, and the terms of a geometric sequence are a subset of the range of an exponential function.
<b>Interpreting Functions</b> <i>Interpret functions that arise in applications in terms of the context.</i>	
<b>NC.M1.F-IF.4</b>	Interpret key features of graphs, tables, and verbal descriptions in context to describe functions that arise in applications relating two quantities, including: intercepts; intervals where the function is increasing, decreasing, positive, or negative; and maximums and minimums.

<b>Interpreting Functions</b> <i>Analyze functions using different representations.</i>	
NC.M1.F-IF.7	Analyze linear, exponential, and quadratic functions by generating different representations, by hand in simple cases and using technology for more complicated cases, to show key features, including: domain and range; rate of change; intercepts; intervals where the function is increasing, decreasing, positive, or negative; maximums and minimums; and end behavior.

## Linear, Quadratic, and Exponential Models

*Interpret expressions for functions in terms of the situation they model.*

Interpret the parameters  $a$  and  $b$  in a linear function  $f(x) = ax + b$  or an exponential function  $g(x) = ab^x$  in terms of a context.

## Geometry

### Expressing Geometric Properties with Equations

*Use coordinates to prove simple geometric theorems algebraically.*

Use coordinates to solve geometric problems involving polygons algebraically

- Use coordinates to compute perimeters of polygons and areas of triangles and rectangles.
- Use coordinates to verify algebraically that a given set of points produces a particular type of triangle or quadrilateral.

- Determine if two lines are parallel, perpendicular, or neither.

## Statistics and Probability

### Interpreting Categorical and Quantitative Data

*Summarize, represent, and interpret data on a single count or measurement variable.*

## Interpreting Categorical and Quantitative Data

*Summarize, represent, and interpret data on two categorical and quantitative variables.*

Represent data on two quantitative variables on a scatter plot, and describe how the variables are related.

**NC.M1.S-ID.6a**

a. Fit a least squares regression line to linear data using technology. Use the fitted function to solve problems.

**NC.M1.S-ID.6b**

b. Assess the fit of a linear function by analyzing residuals.

**NC.M1.S-ID.6c**

c. Fit a function to exponential data using technology. Use the fitted function to solve problems.

## Interpreting Categorical and Quantitative Data

*Interpret linear models.*

Interpret in context the rate of change and the intercept of a linear model. Use the linear model to interpolate and extrapolate predicted values. Assess the validity of a predicted value.

Analyze patterns and describe relationships between two variables in context. Using technology, determine the correlation coefficient of bivariate data and interpret it as a measure of the strength and direction of a linear relationship. Use a scatter plot, correlation coefficient, and a residual plot to determine the appropriateness of using a linear function to model a relationship between two variables.
