VOIP Telephone Services

Released July 2024

Objective:

The objective of this Request for Proposal (RFP) is to solicit proposals from qualified vendors for the procurement of Voice Over Internet Protocol (VOIP) phones for Halifax County Schools.

Scope of Work:

Halifax County Schools is seeking VOIP services at all sites across the district. The selected vendor will be responsible for the following:

- 1. Providing VOIP service compatible with existing Polycom handsets.
- 2. Providing services for 53 DID telephone numbers.
- 3. Work with Halifax County Schools to eliminate unnecessary DIDs.
- 4. Training for school staff on the use and maintenance of the VOIP phone system.
- 5. Ongoing technical support and maintenance services for the duration of the contract.
- 6. Managing VOIP services at 12 locations.

Requirements:

- 1. Compatibility with existing network infrastructure and ability to integrate with other communication systems used within the school district.
- 2. Robust security features to safeguard sensitive information and ensure compliance with relevant data protection regulations.
- 3. User-friendly dashboard that allows each user access (logins) to include managing calls, messages, and setting voicemail passcode.
- 4. Provide user function that allows users to make and receive phone calls through an app on their cell phones.
- 5. Reliability and uptime guarantee to minimize disruptions to school operations.
- 6. Cost-effective pricing structure, including licenses, installation, training, and ongoing support services.

Vendor Requirements:

- The vendor must have at least a five year track record providing the services described in this request for proposal.
- The vendor must provide at least three current references similar to the size and needs of our organization.
- Vendor support must be available 24/7.

Proposal Submission:

Completed submissions should be emailed to <u>requestforbids@halifax.k12.nc.us</u>. Proposals should include the following:

- 1. Company profile and relevant experience in providing VOIP phone solutions to similar-sized school districts.
- 2. Detailed description of the proposed VOIP phone system, including specifications, features, and scalability options.
- 3. Pricing breakdown for licenses, training, and ongoing support services.
- 4. Proposed timeline for implementation and deployment.

5. Three references from current/past educational institutions that are of similar size.

Evaluation Criteria:

Proposals will be evaluated based on the following criteria:

- 1. Compliance with the requirements outlined in this RFP.
- 2. Technical capabilities and suitability of the proposed VOIP phone system.
- 3. Cost-effectiveness and value for money.
- 4. Vendor's experience and track record in serving similar-sized school districts.
- 5. Quality of proposed services.
- 6. References and client testimonials.

Selection Process:

The selection of the vendor will be based on the evaluation of proposals received. Halifax County Schools reserves the right to reject any or all proposals or to waive any informality or irregularity in the proposals received. The selected vendor may be required to participate in negotiations to finalize the terms and conditions of the contract.
