MINUTES

The Halifax County Board of Education met in session on Monday, November 3, 2008. The meeting was held the central office administrative building located in Halifax, North Carolina.



Ms. Middleton gave a little background information regarding the new executive/principal's evaluation (which also includes the teacher evaluations and superintendent's evaluation). She introduced Mr. Reginald Wilkerson from the Department of Public Instruction to share a little more about the evaluation, which went into effect July 1. He shared a copy of the manual with each board member. We began this process last November 2007. One of the things we are doing is making sure that all principals are trained and tracked.

This is a Linear Process:



Goals need to be set. Evaluators have been advised to not wait until mid-year to find out if someone is progressing or not progressing.

Mr. Callihan, Finance Officer shared a financial update with the board members. At the January meeting he will be rebalancing the state and local budgets.

Ms. Middleton introduced Mrs. Flora Pitchford who has worked diligently along with her staff to get the Ecology and Environmental Studies Magnet Program to where it should be. Magnet schools were a way in the 1970's for school systems to dissegregate. Magnet schools have tripled in the last decade. They fit the needs of the community. There are approximately 2 million students enrolled in magnet programs today.

This is an interdisciplinary approach. Three hour/two-block class. There is a common planning period. Some of the advantages are:

- -Technology (computer access in the classroom and laptops)
- -All classes in the same vicinity
- -Working, supportive relationship of the staff
- -Rapport between students and staff
- -Emphasis on student group work and collaboration
- -Student support for one another.

SUPERINTENDENT COMMENTS:

- o Reported that Senator Edward Jones and Representative Angela Bryant and Board Chairman Tyrone Williams coordinated an Anti-Gang, Drug and Student Violence Forum, which was held at Southeast. There is a grant available for all agencies to work together toward this effort. Cynthia Harris of CJH Educational Grant Services will be meeting with staff on November 10th.
- o A Student Advisory Council is being coordinated through Keith Hoggard and Mabel Taylor. I met with them on October 21st. Students were very positive. Some of the things discussed were: SGA, AVID Program, Healthy Alliance, and Leadership Academy in Montana. Many of the students were pleased for the opportunity that their schools had reworked schedules so that they could work on health. Mrs. Wendy Edmonds of the RTED Group has opportunities that will work for these students through an Emerging Leaders Program.
